ORDER:

The Inspector General of Registration, in his letter read above, has stated that the provisions contained in Clause (3) of Article 3 of the Table of Fees prepared under section 78 of the Registration Act, 1908 provides for levying extra fee of Rs.100/- towards copying of document done with the help of electronic devices and that at times, voluminous documents are prepared and presented by the Public for registration and that due to this, the workload relating to affixing page endorsement certificate and scanning of document increases considerably and such documents occupy more space in the storage device. He has further stated that the services rendered by the department in attending to such documents is not commensurate with the fee already prescribed and has therefore stated that the extra fee mentioned above may be levied on the basis of number of pages used in the instrument to defray the cost incurred in scanning and storing the documents. The Inspector General of Registration has proposed that for upto 10 pages of a document, the extra fee levied shall be Rs.100/- (Rupees one

hundred only) as at present and for every additional page Rs.15/- (Rupees fifteen only) shall be levied.

2. The Government examined the proposal of the Inspector General of Registration and have decided to accept the same. Accordingly, the Government direct that the notification appended to this order will be published in an extraordinary issue of the Tamil Nadu Government Gazette, dated 30/5/2014. The Works Manager, Government Central Press is requested to send 100 copies to Government and 1000 copies to the Inspector General of Registration of the gazette in which the notification is published.

NOTIFICATION

Under section 78 of the Registration Act, 1908 (Central Act XVI of 1908), the Governor of Tamil Nadu hereby makes the following amendment to the Table of Fees published with the erstwhile Judicial Department Notification No.177, dated the 30th March 1909 at pages 316 to 319 of Part I of the Fort St. George Gazette, dated the 30th March 1909, as subsequently amended:-

2. The amendment hereby made shall come into force on the 2nd June 2014.

AMENDMENT.

In the said Table of Fees, in Article 3, the following clause shall be substituted, namely:-

"(3) Registration under sub-section (1) of section 70-B extra fee of

100.00, inclusive of scanning charges for the first ten pages of the document and Rs.15/- for every additional page above ten pages."


